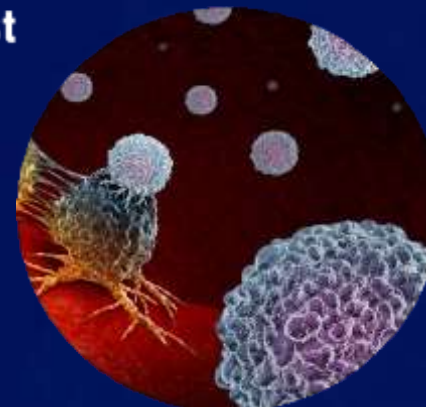
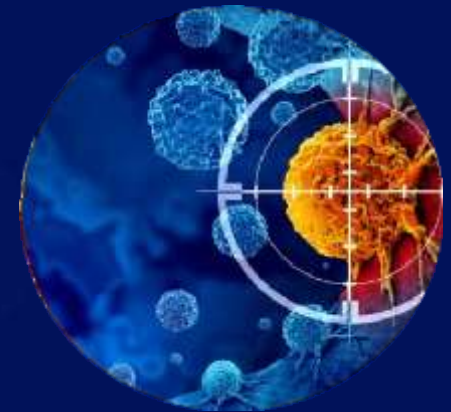
# ABOUT UTR THERAPEUTICS

## Unique Tokenisation of UTR:

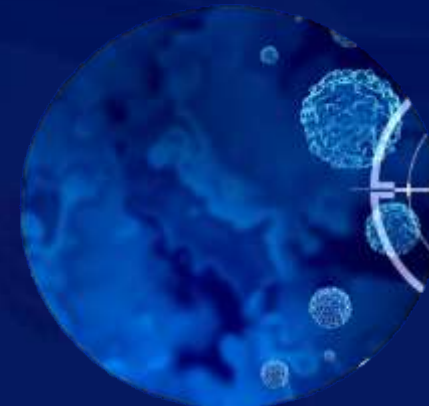
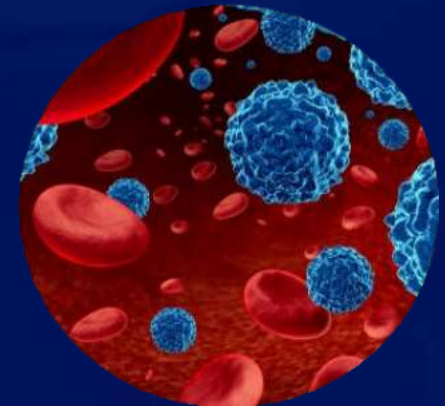

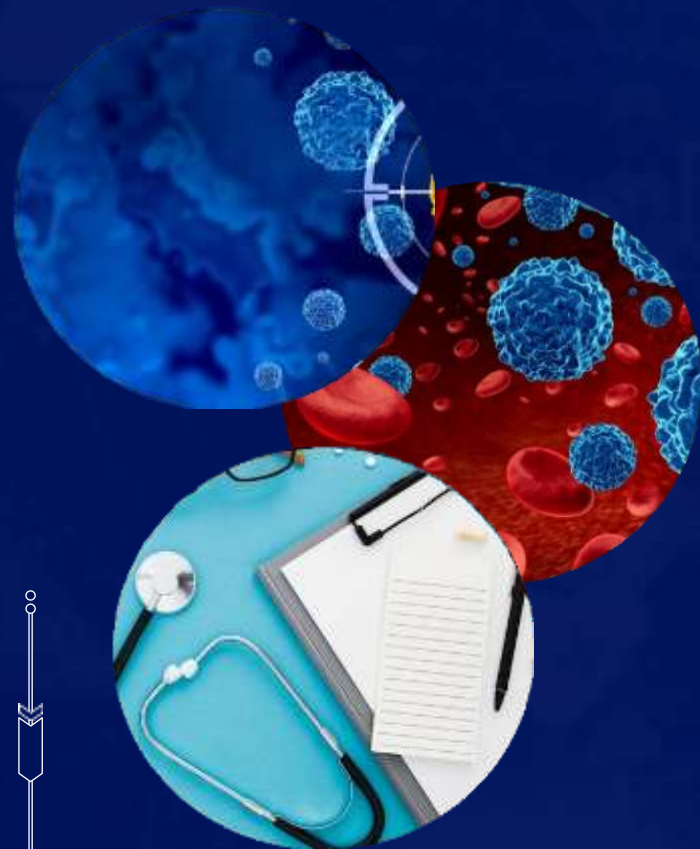
# UTR TNBC ECOSYSTEM

- **10% For Marketing:** This will be for the initial marketing of the UTR TNBC token ensuring its entrance into the public market and for exchange and MM requirements.

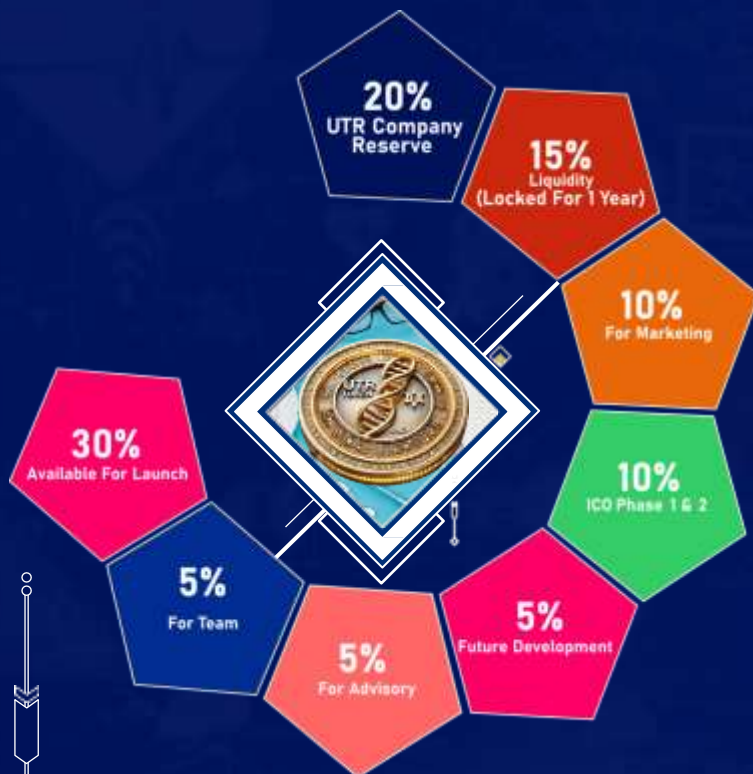
- **10% ICO PHASE 1 & 2:**
